

PRIMARY AND GENERAL ELECTION NOTICE OF OFFICES TO BE FILED BY
ELECTION AND FILING DEADLINE

I, Shannon Wragge, Pierce County Clerk and Election Commissioner, hereby give notice of the offices to be filled by election that will appear on the 2012 Primary Election Ballot to be held May 15, 2012, in Pierce County, Nebraska, as per State Statute 32-601. **Notice is also given that the filing deadlines for such offices are: February 15, 2012 for incumbents and March 1, 2012, for non-incumbents. An incumbent is anyone serving in an elective office, even if they are filing for an office other than the one in which they are presently serving, they are required to file by February 15, 2012.**

NAME OF OFFICE: (vote for one unless otherwise indicated)

President of the United States; United States Senator; Representative in Congress-3rd District.

State Ticket: UNL Board of Regents, District 3; State Board of Education, District 3; State Legislature, District 41; Member of Board of Governors, Northeast Community College-District One and At Large; Lower Elkhorn NRD-Sub-District One.

County Ticket: County Commissioner-District One; Delegates to County Convention.

City Ticket: City of Pierce-2 Council Members; City of Plainview-2 Council Members; City of Osmond-Mayor and 2 Council Members.

Board of Education: School District #2 Pierce-3 Board of Education Members; School District #5 Plainview-3 Board of Education Members; School District #42 Osmond-3 Board of Education Members; School District #76 Wausa, Knox County-3 Board of Education Members (4 Yr Terms) and 1 Board of Education Member (2 Yr Term); School District #13 Creighton, Knox County-3 Board of Education Members; School District #45 Randolph, Cedar County-3 Board of Education Members; School District #9 Neligh-Oakdale, Antelope County – 3 Board of Education Members; School District #2 Norfolk, Madison County – 3 Board of Education Members; School District #5 Battle Creek, Madison County – 3 Board of Education Members; and School District #80 Tilden(Elkhorn Valley), Madison County-3 Board of Education Members (4 Yr Terms) and 1 Board of Education Member (2 Yr Term).
