COMMISSIONERS PROCEEDINGS

September 11, 2017

The Pierce County Board of Commissioners met pursuant to adjournment on Monday, September 11, 2017, at 9:10 A.M. with the following members present: Marvin Elwood, Jr., Brad Albers and Terry J. Wragge. Co. Clerk Shannon Wragge and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Wragge called the meeting to order at 9:15 A.M. and presided. Chairman Wragge stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.

Motion by Albers, seconded by Elwood, to approve the agenda and minutes. Roll call vote: Aye: Elwood, Albers and Wragge. Nay: None. Motion carried.

The minutes of August 28, 2017 were approved as printed.

Motion by Wragge, seconded by Albers, to Approve and Appoint Ryan Zimmerman to the Pierce County Planning & Zoning Board for a term of 3 Years. Roll call vote: Aye: Elwood, Albers and Wragge. Nay: None. Motion carried.

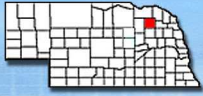
Discussion was held on the Plainview East and Pierce South Unbonded Concrete Overlay Projects #160973/#160974.

Motion by Elwood, seconded by Albers, to Authorize & Approve the Chairman to sign Change Order #3 (Final) (increase of \$14,014.00 to bring new total to \$1,127,061.70), Pay Application #2 (\$85,066.38) and Certificate of Substantial Completion to A & R Construction Co., Plainview, NE for the Pierce South/Plainview East Unbonded Concrete Overlay Project #160973/16974. Roll call vote: Aye: Elwood, Albers and Wragge. Nay: None. Motion carried.

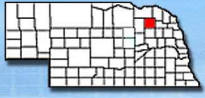
