COMMISSIONERS PROCEEDINGS

November 13, 2023

The Pierce County Board of Commissioners met pursuant to adjournment on Monday, November 13, 2023, at 9:10 A.M. with the following members present: Brad Albers and Carl Martinson; Tom Kuether was absent. Co. Clerk Shannon Wragge, Co. Assessor Jean Lubke, EMS Bobbi Risor, Zoning Adm. Heather McWhorter, Co. Attorney Ted Lohrberg, Hwy Supt. Brian McDonald, Michelle Reikofski, Blaine Bockelman, Shauna Gossman, Josh Gossman, Keith Sunderman, Bonita Lederer, Brent Neice, Sheryl Prince, and News Reporter Randee Falter were present.

Motion by Martinson, seconded by Albers, to appoint Brad Albers as Chairman Pro Tem due to the absence of Chairman Tom Kuether. Roll call vote: Aye: Albers and Martinson; Kuether absent. Nay: None. Motion carried.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Pro Tem Albers called the meeting to order at 9:10 A.M. and presided. Chairman Pro Tem Albers stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.

The legal was read for the 9:15 a.m. opening of sealed bids for the construction of Breslau North & Pierce North-JEO Project #221895 and #230074. The bids were opened in the presence of all present. The following two bids were received: (1) Vogtscapes, Bennet, NE, at a total cost of \$506,245.00 with a start date of March 2024 and (1) A & R Construction Co, Plainview, NE, at a total cost of \$467,581.53 with a start date of August 10, 2024.

A RESOLUTION GRANTING A CONDITIONAL USE PERMIT FOR CERTAIN LAND LOCATED IN THE COUNTY OF PIERCE, NEBRASKA UNDER AUTHORITY GRANTED BY THE PIERCE COUNTY ZONING AND SUBDIVISION RESOLUTION AND LEGISLATIVE BILL 186 (1978)

WHEREAS, the Pierce County Planning Commission and the Pierce County Board of Commissioners, having given proper notice and holding public hearings as provided by law and under the authority of and subject to the provision the Pierce County Zoning and Subdivision Resolution and Legislative Bill 186 (1978).

WHEREAS, the Pierce County Planning Commission and the Pierce County Board of Commissioners have established the following Statement of Finding of Facts for the Conditional Use Permit application of Aaron Stech:

- 1. The application is consistent with the Pierce County Comprehensive Plan.
- 2. The application is consistent with the Pierce County Zoning and Subdivision Regulations.
- 3. Located in the A-1 Ag Intensive district.
- 4. Waiver has been provided for the home that is inside the ¼ mile setback.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Pierce County, Nebraska, hereby grants a Conditional Use Permit to Josh Gossman to operate a medium hog operation of up to 1350 swine under Section 402, Subsection B, Part 29, "A-1" Primary Agricultural District, Pierce County Zoning and Subdivision Resolution, on the following described land:

E ½ SW ¼ minus a 5-acre tract located in Section 10, Township 25 North, Range 1 West of the 6th P.M., Pierce County, Nebraska. (see attached)

This Conditional Use Permit shall be subject to the following conditions in addition to those established with the Pierce County Zoning and Subdivision regulations:

- 1. This is a Medium Livestock Feeding Operation Conditional Use Permit for an operation of up to 1,350 swine.
- 2. All manure shall be applied on property as shown on the manure management plan developed by the applicant in accordance with Nebraska Title 130.
- 3. This conditional use permit shall be for a period of twenty years and will become effective with the adoption of this resolution. This permit is subject to all the Pierce County Zoning and Subdivision Regulations and the governing powers of the State of Nebraska and shall be constructed to meet both groups.
- 4. This conditional use permit shall become invalid if the application with Nebraska Department of Environment & Energy is not approved within one year of adoption of this resolution.
- 5. The permit may be transferred to a new owner, provided the Zoning Administrator is notified at least 30 days prior to closing.
- 6. A zoning permit must be obtained before beginning construction on any buildings.

NOW, THEREFORE, BE IT FUTHER RESOLVED, that upon taking effect of this Resolution, the above Conditional Use Permit shall be entered and shown on the Official Zoning Map of Pierce County, previously adopted by reference, and said zoning map is hereby reincorporated as a part of the Pierce County, Nebraska Zoning and Subdivision Resolution as amended.
