No Candidate or any person serving on a campaign committee for a candidate shall act as agent for any registered voter requesting an absentee ballot unless such person is a member of the registered voter's family. No person shall act as agent for more than two voters for any one election. The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.

Early Voter Deadline for Tuesday, November 3rd, 2020 General Election is:

Request by Mail: 4:00 P.M., Friday, October 23, 2020
Request in Person: 4:30 P.M., Monday, November 2, 2020
Request by Agent: 7:00 P.M., Tuesday, November 3, 2020

Ballots returned by agent must be returned by 8:00 P.M. on Election Day.

Ballots returned by mail must be in the possession of the Election Office by 8:00 P.M. on Election Day.
