No Candidate or any person serving on a campaign committee for a candidate shall act as agent for any registered voter requesting an early voters ballot unless such person is a member of the registered voter's family. No person shall act as agent for more than two voters for any one election. The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.

Early Voter Deadline for Tuesday, May 12th, 2020 Primary Election is:

Request by Mail: 4:00 P.M., Friday, May 1, 2020

Request in Person: 4:30 P.M., Monday, May 11, 2020

Request by Agent: 7:00 P.M., Tuesday, May 12, 2020

Ballots returned by agent must be returned by 8:00 P.M. on Election Day.

Ballots returned by mail must be in the possession of the Election Office by 8:00 P.M. on Election Day.
