No Candidate or any person serving on a campaign committee for a candidate shall act as agent for any registered voter requesting an absentee ballot unless such person is a member of the registered voter's family. No person shall act as agent for more than two voters for any one election. The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.

Request by Mail: 4:00 P.M., Friday, October 28, 2022

Request in Person: 4:30 P.M., Monday, November 7, 2022

Request by Agent: 7:00 P.M., Tuesday, November 8, 2022

Ballots returned by agent must be returned by 8:00 P.M. on Election Day.
