No Candidate or any person serving on a campaign committee for a candidate shall act as agent for any registered voter requesting an early voters ballot unless such person is a member of the registered voter's family. No person shall act as agent for more than two voters for any one election. The penalty for election falsification is imprisonment for up to five years, or a fine not to exceed \$10,000.00 or both.

Early Voter Deadline for Tuesday, May 10th, 2022 Primary Election is:

Request by Mail: 4:00 P.M., Friday, May 2, 2022

Request in Person: 4:30 P.M., Monday, May 9, 2022

Request by Agent: 7:00 P.M., Tuesday, May 10, 2022

Ballots returned by agent must be returned by 8:00 P.M. on Election Day.

Ballots returned by mail must be in the possession of the Election Office by 8:00 P.M. on Election Day.

Nebraska Voter Registration Application forms are available at the Pierce County Clerk's Office during regular business hours. (In person voter registration deadline is May 2nd at 6:00 pm)
